UPON hearing the counsel the Court made the following  
 O R D E R

Learned counsel representing respondent no. 7 - State of West Bengal submits, that the concerned authorities of the State have fully complied with the impugned order passed by the High Court on 09.12.2015, read together with, the interim order passed by this Court on 10.05.2016.

In order to substantiate his contention, learned counsel has placed reliance on 'Annexures F dated 11.11.2016' and 'Annexure G dated 16.11.2016' respectively, depicting a direction to release the salary of 12 and 09 contempt petitioners respectively.

Though, we do not doubt the bona fides of the State of West Bengal, we consider it just and appropriate to require the

State of West Bengal, to determine whether the aforesaid 21 teaching and non-teaching staff have indeed been paid their salary. The State of West Bengal shall obtain instructions, and file an affidavit in this Court depicting the release of the salary to the teaching and non-teaching staff.
